

# CropScanAg N-GAUGE Mobile App Data Policy

The following document outlines the Data Policy for CropScanAg Solutions' N-GAUGE Mobile App.

## 1.0 Description:

CropScanAg Solutions Pty Ltd has built the N-GAUGE app which is available to users of the CropScan On Combine Grain Analyser to download free from the app stores. This SERVICE is provided by CropScanAg Solutions Pty Ltd at no cost to download and is intended for use with a product licence and linked to a CropScanAg Cloud account.

The N-GAUGE app is the user interface for users to interact with data collected from CropScan On Combine Grain Analysers. This data is stored securely in the CropScanAg Cloud and is viewed and managed through the N-GAUGE app.

This page is used to inform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

## 2.0 Information Collection and Use

The app does not use third party services that may collect information used to identify you.

## 3.0 Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.
